# Guidelines and criteria for the submission of **SUB-THEME PROPOSALS** for EGOS Colloquia



**Sub-theme proposal submissions** are expected to include an outline of the proposed theme and the related area of interest (maximum of 2 pages), as well as a short description of the team of convenors, including their academic background and experience. Submissions should to be linked with the overall Colloquium theme, but other submissions are also welcome. The sub-theme proposals should avoid repetition of the overall Colloquium theme in their titles.

### Convenor teams of an EGOS Colloquium should conform to the following principles:

- They should be <u>international</u> in composition (convenors from at least two countries) and should include at least <u>one highly reputed scholar</u> and <u>one convenor experienced in organizing EGOS sub-themes</u>.
- The maximum convenor team size is <u>three scholars</u>; proposals from teams of four or more convenors cannot be considered!

**Submission period** [via the EGOS website] for sub-theme proposals for the 33<sup>rd</sup> EGOS Colloquium in Copenhagen, Denmark, July 6–8, 2016:

- Start: Wednesday, October 14, 2015
- End: Wednesday, November 25, 2015, 23:59:59 CET
- To submit (and upload) a sub-theme proposal, the main submitter/convenor has to be (a) <u>either</u> a so-called "registered user" or (b) an active (or former) EGOS member:
  - If you have neither been an active EGOS member, nor a registered user, nor ever uploaded a short paper or a sub-theme proposal for the EGOS Colloquia, <u>you first of all need to become a registered user!</u> Please click on "**Join EGOS here**" at the top of the EGOS website.
  - If you are an active or former EGOS member, log in to "MyEGOS" using your EGOS member number or email address + your password.
- After having logged in with your EGOS member or registered user number, please go to your MyEGOS and click on (Copenhagen 2017) "Submit your sub-theme proposal".

# Please fill in the form [all boxes marked with \* are mandatory!]

- Sub-theme title please do not use capital letters!
- Proposal: brief summary no more than 150 words.
- Proposal file = outline of the proposed theme and the related area of interest (max. 2 pages), and a short description of the convenor team, inc. their academic background and experience.
  - → Please <u>upload</u> your proposal in .doc, .docx or .pdf format!
- Keywords no more than 7
